Covid-19 is a new illness that can affect your lungs and airways. It is caused by a virus called Coronavirus. Symptoms can be mild, moderate, severe or even fatal.

This is a **Risk Assessment** for dealing with the current Covid-19 situation in the workplace. It is not likely to cover all scenarios and each employee should consider their own unique circumstances ie. Underline health issues, the health of family members with underline health issues and elderly members of their family. This `Risk Assessment` will be reviewed daily in-line with Government recommendations and advise.

What are the hazards? - Spread of Covid-19 (Coronavrus)

Risk Rating	Recommended Action

High	Task or activity should be suspended and remain so unless control measures to eliminate or adequately reduce risk can be introduced within 1 month
Medium/High	Control measures need to be introduced within 3 months
Medium	Control measures need to be introduced within 6 months
Low	Control measures to be introduced on a medium to long term basis i.e. as equipment is renewed or as part of a planned programme of improvements

Shift 1 – 7.45am to 3.45pm Shift 2 – 8.00am to 4.00pm Shift 3 – 8.15am to 4.15pm</p> <p>A 2.0m gap between the bench operators on the production line and canteens are now in operation. By making these changes it is removing the chance of close contact in these areas.</p> <p>(See pictures attached).</p>

	<p><u>Wearing of Gloves/Masks</u> Where Risk Assessment identifies wearing of gloves/masks as a requirement of the job, an adequate supply of these will be provided. Staff will be instructed on how to remove gloves/masks carefully to reduce contamination and how to dispose of them safely.</p> <p><u>PPE</u> Public Health guidance on the use of PPE (personal protective equipment) to protect against COVID-19 relates to health care settings. In all other settings individuals are asked to observe social distancing measures and practice good hand hygiene behaviours</p> <p>Where PPE is a requirement for risks associated work, the company will supply it.</p> <p><u>Symptoms of Covid-19</u> If anyone becomes unwell with a new continuous cough, high temperature, loss of taste or smell in the work-place, they will be sent home and advised to follow the stay at home guidance and contact 111. 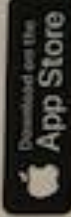

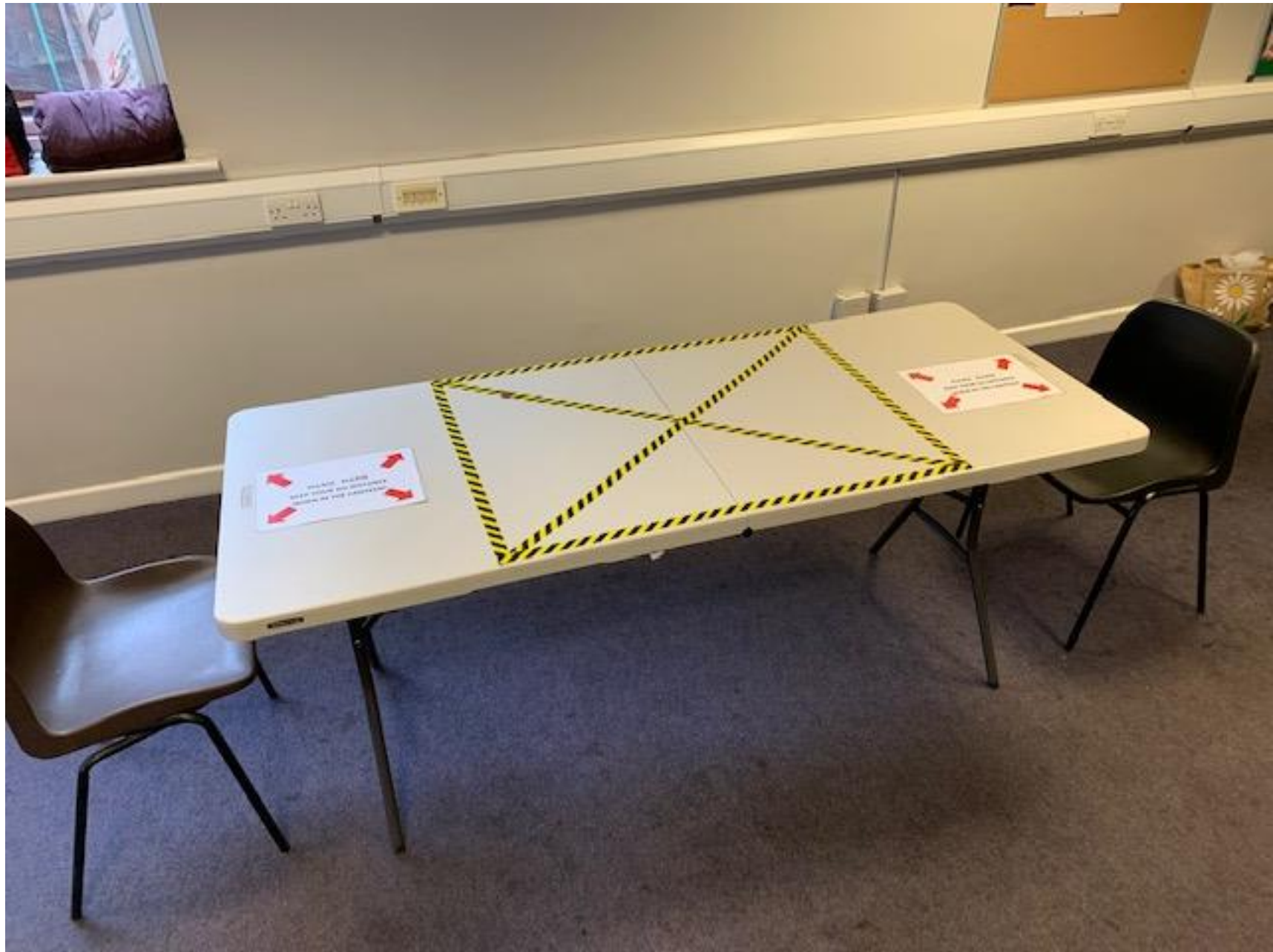

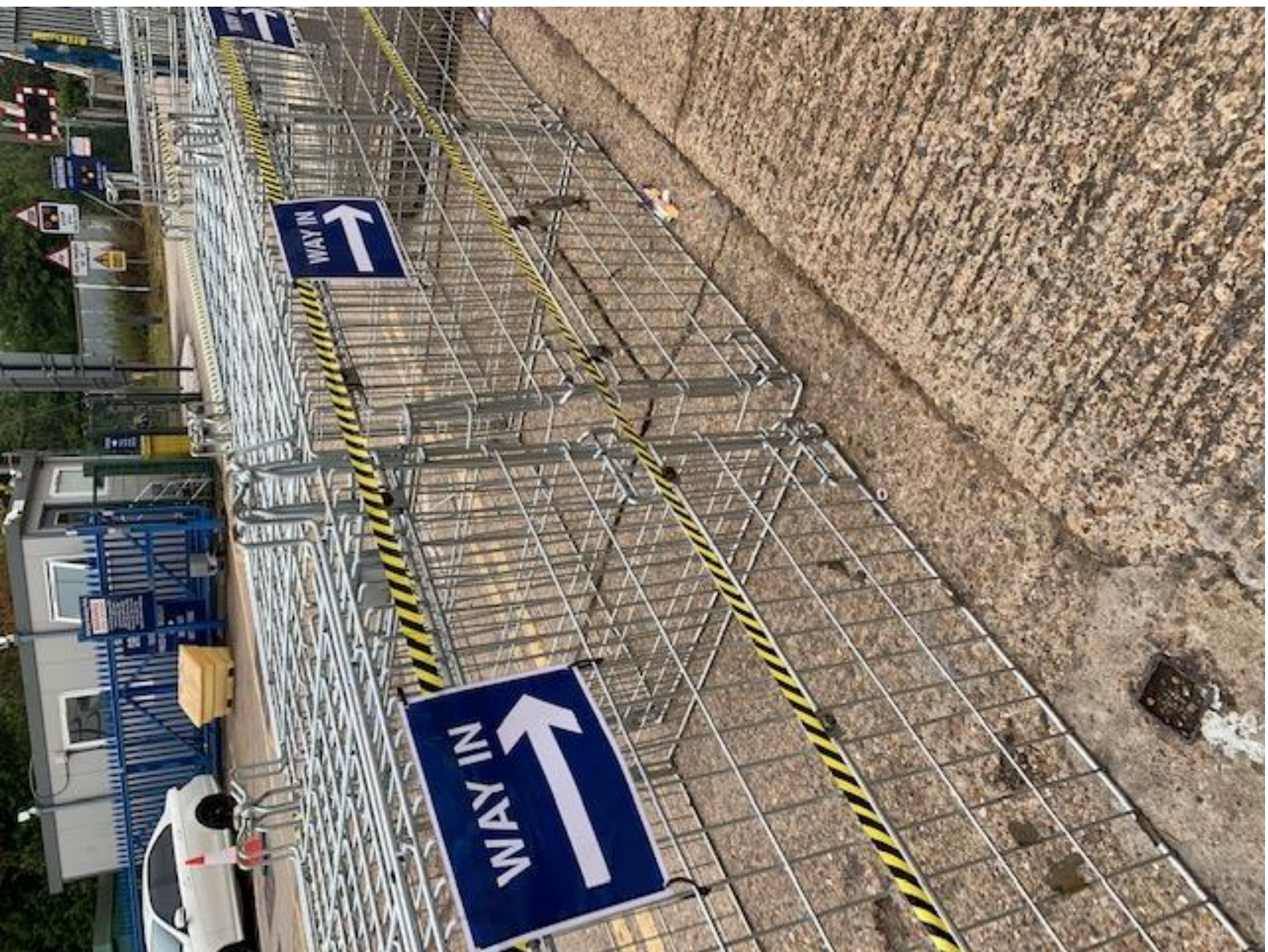

Cough



Fever



Difficulty breathing

- If you are **NOT** registered with a GP in Northern Ireland, please contact your local Emergency Department by checking pha.site/emergency-healthcare-direct.
- Please do **NOT** attend the surgery or hospital without phoning in advance.
- If it is a medical emergency, call 999 and inform the call handler of your recent travel.

Even if you have no symptoms, if you have been to:

- Hubei Province (including Wuhan), China in the last 14 days; or
- Iran, specific lockdown areas in Northern Italy, or special care zones of South Korea since February 19th 2020; please return home, contact the helpline on 0300 200 7665 and follow the advice below.



Stay indoors and avoid contact with others as much as possible for 14 days after you arrive.



Do not go to work, school or public areas



Avoid visitors in your home



Do not use public transport or taxis
